## TRUSTEES' REPORT For the year ended 31 December 2016

---

The trustees who are also Directors of the Charity for the purposes of the Companies Act present their report with the financial statements of the charity for the period 1 January 2016 to 31 December 2016. The financial statements have been prepared in accordance with the Charities Act 2011 and the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective January 2015) and comply with the charity's governing document.

### OBJECTIVES AND ACTIVITIES

The Swiss Church is a Spiritual Home to the Swiss in the UK.

As a Swiss **Church**, it is a member of the one universal, apostolic and holy Church of Christ. Its foundation is the word of God as witnessed in both the Old and the New Testament. The Swiss Church, affiliated to the Federation of Swiss Protestant Churches in Berne, adheres to its roots in the Swiss Reformation of the 16th Century. It strives to proclaim God's word according to the principles set out by the Reformation, in particular by John Calvin and Huldrych Zwingli.

In their spirit, the Swiss Church encourages its members to actively explore the Christian faith and to find a personal belief based on reflection and experience.

It seeks to further and strengthen Christian love, solidarity, justice and truth. In ecumenical openness, the Swiss Church welcomes Roman Catholics and Christians of all other denominations.

As a **Swiss** Church founded by French speaking Swiss in the 18th Century and later united with the German-speaking congregation, it is a meeting place for all Swiss and friends of Switzerland from all walks of life. The Swiss Church seeks to contribute actively to the social life of the Swiss community in London and promotes cultural and social activities to strengthen friendship and understanding.

As a **Swiss Church** it believes that both aspects, its being a Church and its being a Swiss institution are inseparably intertwined and stimulate each other.

**Public benefit**

In setting our objectives and planning our activities the board of trustees has given careful consideration to the Charity Commission's general guidance on public benefit, and in particular, to its supplementary public benefit guidance on advancing religious education.

**Safeguarding Policy**

We acknowledge children's and adults right to protection from abuse, regardless of gender, ethnicity, disability, sexuality or beliefs. We consider that the welfare of children is paramount. We will follow legislation, statutory guidance and recognised good practice in order to protect vulnerable people in our church and continue our adherence to an ongoing safeguarding policy.

**REVIEW OF ACHIEVEMENT AND PERFORMANCE**

During 2016 the focus has continued to work towards the objectives listed below:

- Make the Swiss Church better known among the Swiss in London, visitors and the local community as a spiritual home and a meeting place. This was encouraged with the introduction of regular family activities, a young professionals and students network and an increase in traditional Swiss events as well as in outreach and community activities.
- Increasing fundraising activities to become financially self-sufficient.
- Improve and strengthen governance structures and recruit new trustees
- Recruit new volunteers and provide training for staff and volunteers.
- To be better connected with charities, churches and other organisations in the neighbourhood and the borough of Camden.
- To strengthen the network and joint activities with the wider Swiss community.
- To upgrade the IT system, office infrastructure and improve data safety.
- To create and launch a new webpage.

**Services, pastoral care and spiritual life**

A total of 25 services were celebrated including Easter Sunday service, a commemorative service and an extraordinary service in German with a visitor group from the Reformed Church in Thun, Switzerland. One service was celebrated with the Reverend of the Great Minster in Zurich, Christoph Sigrist. Family services were held at Easter and Christmas.

Midweek prayers were hold regularly on Thursday evenings and Friday afternoon. In September it was decided to stop the weekday prayers due to low attendance.

Helena Dias was baptised on 15 May 2016. Naira Hefstone was baptised on 18 September 2016.

Ramon Cadusch was confirmed at the Swiss Church on 19 July 2015.

Rev. Carla Maurer conducted three funeral services.

The members of the congregation again appreciated the friendship and fellowship they are able to experience at the lunches following the services thanks to the help of many volunteers, co-ordinated by Cécile Mistry, who arranged and prepared a variety of delicious meals.

Rev. Carla Maurer paid home visits to members of the Church. Swiss groups and societies such as the Frauenverein, the Mothers' Group and La Causerie met regularly at the Swiss Church. Rev. Carla Maurer led bible studies and prayers for the Mothers' group and the Frauenverein.

As a member of the Ecumenical Forum of European Christian Women (EFECW), Rev. Carla Maurer participated in the General Assembly in Larnaca, Cyprus from 27 June – 1 July 2016.

### **Community and Outreach Work**

The community programme is aimed at the Sunday congregation, Swiss people living in London, and the community in the locality of the church. The church continues to welcome people to weekly events such as 'Breakfast on the Steps' and 'Holy Soup' and to one off events such as screening football games of the Swiss National team. At the vicarage, Rev. Carla Maurer and husband Julian Simmons hosted homeless asylum seekers through charity Housing Justice to help those in need of a place to stay.

Community and Outreach Worker Matt Stone left the team in July 2016. Lilian Jost from Switzerland started working part-time (2 days) as the new Community and Family Worker on 16 August 2016. The following activities were organised in the past year.

On 12/13 April 2016, eighteen participants went on a parish trip to Bruges in Belgium. The group visited various places of interest including the lace museum.

A visit was organised to Highgate Cemetery on 29 October 2016, followed by a 'death café' where participants had the opportunity to share their thoughts about dying and death.

On 6 October, Kevin Brown, Archivist at Imperial College, held a talk about Endell Street Hospital which was located opposite the Swiss Church and was the first hospital in England run by women.

Family activities included a Scavenger Hunt on 18 June 2016, the traditional Swiss 'Räbeliechtliumzug' (Turnip Parade), held on 5 November 2016, and the visit of the 'Samichlaus' (Santa Clause) which took place on 4 December 2016. Twenty to thirty children and their parents joined each of the events which were both coordinated by a committed group of volunteers. The family Christmas service was held in the woods (Queen's Wood, North London) on 11 November 2015.

The Swiss Church team together with a number of volunteers coordinated the children's programme at the Swiss National Day (SND) celebrations on 16 July 2015. This included face painting, lantern making, children's games and dance workshops. All team members regularly attended SND committee meetings which were held at the Swiss Embassy.

The Swiss Church Mothers Group as well as the Frauenverein and La Causerie met monthly at the Swiss Church to maintain longstanding relationships between Swiss migrants and offer assistance to the elderly.

Rev. Carla Maurer occasionally led prayer meetings and bible groups. The Mothers Group was invited to the vicarage for a BBQ.

Rev. Carla Maurer together with husband Julian Simmons regularly invited to informal meetings ('BYO evening') for young Swiss professionals and students at the vicarage on 1 Womersley Road. These evenings attracted an average of 15-20 of Swiss people and friends, including a number of new faces.

Rev. Carla Maurer intensified the collaboration with the various Swiss clubs in London and the UK and participated in round table meetings to further the joint efforts of the Swiss clubs to serve the Swiss community and to strengthen the Swiss Church as a meeting place for the Swiss.

#### **Office Administration and Event Venue Management**

Office and Venue Manager Anina Smith went on maternity leave in November 2016 due to return in February 2018 as part-time administrator and accountant. Colin McIntyre will do the accounts in her absence. Lilian Jost will cover administration. James Rasa has been put in charge of the Swiss Church News.

The hiring income continued to increase and contribute to the financial success of the Swiss Church despite of the broadening funding gap. Nat Breitenstein was appointed as new Venue Manager.

Regular and returning clients include Vera the Diva dance school, Covent Garden Talks, Covent Garden Minuet Company, meditation classes, City Lit, Incorporate Association of Organist's, yoga classes and Alzheimer's Society as well as London Fashion Week and Swiss businesses.

The Consistoire hired Kim Yeong as a contractor to deal with some long overdue building maintenance tasks and support the Consistoire with their various tasks.

#### **Fundraising events**

The Fundraising Fondue night took place on 11 February 2016.

The Swiss Church Christmas Fair, which takes place every other year, took place on 26 November 2016 and attracted people from across the UK. The Christmas Fair is a major fundraising event and raised £8,854. A large part were cash contributions ahead of the event.

Rev. Carla Maurer increased her fundraising activities in Switzerland and established a number of new contacts, namely the Reformed Titus Church in Basel, the Reformed Church in Kilchberg near Zurich and the Reformed Church in Dübendorf, and furthered some established contacts.

#### **Internship and sabbatical**

Lilian Jost from Wasterkingen in Switzerland made an internship from 16 March to 15 June 2016.

Niccolò Aliano made an internship from 16 April to 30 July 2016.

**The Visual Arts Committee** comprising of David Beck, Ariane Braillard, Annelore Schneider, Symeon Kyriakopoulos, Carla Maurer and Matt Stone continued to do their work, with the support of Dr David Mollin who left the committee in 2014 but continued to coordinate the yearly exhibition in collaboration with the Goldsmiths College.

From 3-18 March 2016, the exhibition 'Crystalline Vitrine' by artist Richard Mueller and curated by Kirsty White took place as part of the collaboration with the Goldsmiths College.

Kirsty White joined the Art Committee as curator in October 2016 to increase the art interventions at the Swiss Church, especially in the area of performance art

Rev. Carla Maurer in collaboration with volunteer Peter Stäuber initiated the planning of the exhibition HomeLos which will take place in Zurich in 2017. At the centre of the project will be the artistic collaboration between Andrea Gohl and Andy Palfreyman building on the past Swiss Church exhibitions 'Cardboard and Caviar' and 'Endell Street' comparing homelessness in the financial capitals London and Zurich. A planning committee comprising of Rev. Christoph Sigris (Grossmünster), Rev. Patrick Schwarzenbach (Offene Kirche St Jakob Zurich), Richard Reich (JuLL), Andrea Gohl, Andy Palfreyman, Carla Maurer and Peter Stäuber was established.

Jon Driscoll and Annelore Schneider organised two film nights at the Swiss Church:

The film nights were supported by Dragon Hall trust.

The committee's a proposal for 'Kunst am Bau' (site specific installation on the facade of the church) is still under discussion.

**Reformation 500:** The ecumenical preparation group for the reformation year 2017 continued to meet throughout the year. The project was mainly led by interns Niccolò Aliano and Lilian Jost. The project 'Still Reforming – Reformation on London's Doorsteps' took shape and the booklet presenting the monthly activities was printed and distributed.

**Ecumenical relationships:** Matt Stone regularly attended the local ecumenical Minister's breakfast group. Rev. Carla Maurer regularly attended meetings of the German speaking pastors and church workers in London (LoPA).

### **Communication**

The Swiss Church News appeared four times during the year and was mailed to over 700 people in the UK and in Switzerland.

An electronic newsletter was sent out regularly to announce events. The distribution system was changed to MailChimp.

The Swiss Church is active on social media (facebook and twitter) and announces events on various Swiss community facebook pages to reach out to the wider Swiss community in London.

The new webpage built by digital agency company On-Idle was launched in June 2016

### **Renovation Project and Acoustics**

The Acoustics Committee was dissolved and the acoustic intervention put on hold. The proposed option studies were too expensive. The acoustics remain an issue.

The installation of roof blinds to darken the hall for projection purposes, and to protect the organ from sunshine, is still outstanding. Donations towards this have been received from the City Swiss Club and Rose-Marie Breitenstein but further fundraising is required.

### **Maintenance of the Manse (also known as the Vicarage)**

The new boundary wall and gate has been fitted in February 2016 under the guidance of Geoff Fisher.

### **Relationship with Switzerland**

On 11 November 2016, President Johannes Reich and Carla Maurer called the first 'Swiss Church Ambassador' group in Zurich with supporters and former workers of the Swiss Church (including former Minister Nathalie Dürmüller, former President Ursula Jost, former Administrator Nicole Bischof, Rev. Hans Weber from Sempach and General Secretary Martin Peier from the Association of Zurich City Churches where the meeting was held).

**Federation of Swiss Protestant Churches (SEK-FEPS)**

Since the communication of the decision by the SEK on the future funding of the Swiss Church on 1 November 2012 the Consistoire dedicated their attention to providing a concept and a strategy to secure the future of the Swiss Church having to become financially independent from the SEK from 2018. Rev. Carla Maurer was in regular contact with the Commission for Churches Abroad (CHKiA) as well as with representatives of the SEK. Johannes Reich and Carla Maurer opened a dialogue with the SEK to clarify the future status of the Swiss Church in London. SCL has received confirmation that the new SEK constitution (currently under review) will provide the possibility for partner churches to remain connected with the SEK. SCL also opened the dialogue with the Community of Protestant Churches in Europe (GEKE) to explore the possibility of membership.

**Swiss Parish Churches**

Marianne Fisher and Rev. Carla Maurer attended the VEGSIL meeting (Club of former members of the Swiss Church in London) held on 28 August 2016 in Sempach, Switzerland. The VEGSIL granted the Swiss Church £1200 for community work.

**Swiss Groups and Contacts**

Two confirmation classes visited the Swiss Church in 2016: Sempach, Lucerne; Laufenburg, Baselland;. The young people cooked community lunch for the mothers group and had a discussion with people affected by homelessness. They also went to visit different places of worship. Two parish group from Germany also visited the Swiss Church.

**St.Gallen Netzwerktag**

Rev Carla Maurer attended the annual network meeting of the Canton of St.Gallen on 31 October 2015 bringing together people from all areas of expertise with international outreach.

**People**

The Swiss Church in London had an eventful year, with many arrivals and departures.

- We are thrilled to welcome Jon Driscoll amongst the Trustees. Jon is a filmmaker and designer of projections for theatre, having designed many notable west end plays and musicals over the past twenty years. His technical knowledge is a great asset to our Church.
- We are most thankful that Andrea Vendolin joined the Trustees in March 2016. Andrea is an Assistant Professor at the London School of Economics where she teaches Master students and mainly does research on a wide array of topics in economics
- Johannes Reich, who joined the Consistoire in November 2013 and was elected President in December 2015, gave notice to resign his positions as both the President and as member of the Consistoire effective in June 2017 at the AGM. He will move abroad together with his wife and their three children in July 2017.
- Andrea Vedolin, who joined in March 2016 and has been serving as the Company Secretary, gave notice to resign her position effective in June 2017 at the AGM as she will move abroad for professional reasons.

## **FINANCIAL REVIEW**

### **Income**

The income from church related activities for the year was £222,542 compared to £209,805 in 2015.

### **Expenses**

Total expenditure in conjunction with church related activities were £165,365 excluding £31,786 worth of depreciation, compared to £161,538 in 2015.

### **Summary**

The overall net expenditure excluding the brought forward is £25,391. The negative ending balance of the building fund is amounting to £2,562 compared to £13,456 in 2015 and will need to be compensated by inflows from future fundraising activities.

### **Reserves Policy**

It is the policy of the Swiss Church to maintain an Unrestricted Reserve. This is intended to enable the Swiss Church to cope with the unforeseen, which might otherwise affect the organisation's ability to continue our activities. In practice, the Trustees consider that holding unrestricted reserves equivalent to six to twelve months' core costs, excluding those funds represented by fixed assets, and should provide sufficient resources to respond to unexpected adverse changes in the Charity's funding or activities. This is equivalent to between £80,000 and £160,000 based on current costs. This policy will be reviewed annually, when setting budgets, to check if it is still relevant, or if changing circumstances require a modification.

### **Investment Policy**

Investments may only be made after prior approval from the Consistoire and must be made only in the name of the Swiss Church in London.

## **PLANS FOR THE FUTURE**

The Trustees are committed to further implement the Business Concept Plan and, as a result, to strengthen the positive relationship with the Swiss community in London as a whole while expanding the mission activities into the wider local community. The Trustees are also determined to both broaden and deepen the relationship with various Swiss Parishes and Cantonal Churches.

In view of the financial independence of the Church, the Trustees are committed to broaden the sources of revenues by reviewing the letting strategy and intensifying fundraising activities.

We are currently working towards a more effective governance structures with each member of the Consistoire having specific duties and responsibilities assigned. This should allow for both informed and swift decision-making.

Recruiting more Trustees remains one of our main targets for the coming year.

**STRUCTURE, GOVERNANCE AND MANAGEMENT**

**Constitution and organisational structure**

The Swiss Church in London is a Charitable Company limited by guarantee and is governed by its Memorandum and Articles of Association adopted on the 5<sup>th</sup> June 2002. The Swiss Church in London was founded in 1762. The company commenced operations on 1 January 2003 when it took over all activities of the Unincorporated Association with the same name. The Consistoire (Voluntary Board of Trustees) oversee the activities and are accountable for the way the resources are used. The Trustees meet every two months, or more or less often if they so decide. The members who served on the Board throughout the year under review are named under Legal and Administrative Information.

The Consistoire is the Governing Body of the Swiss Church in London and administers and manages the Swiss Church in London, its property and its internal and external affairs in accordance with the Memorandum and Articles of Association. The Consistoire makes all major decisions; certain powers of delegation are granted to the Minister, as well as to special task groups and individual members of the Consistoire.

**Recruitment and appointment of new trustees**

The appointment and removal of Trustees is decided by a majority of votes. At every Annual General Meeting, one-third of the Trustees shall retire from office. The retiring Trustees shall be eligible for re-election.

**Induction and training of new trustees**

Induction of Trustees takes place through one to one sessions with the Chair. If needed, additional training is arranged.

**Risk management**

The Trustees have a duty to identify and review the risks to which the charity is exposed and to ensure appropriate controls are in place to provide reasonable assurance against fraud and error.

**STATEMENT OF TRUSTEES' RESPONSIBILITIES**

In preparing these financial statements, the Trustees are required to:

- select suitable accounting policies and then apply them consistently;
- make judgements and estimates that are reasonable and prudent;
- state whether applicable UK Accounting Standards have been followed, subject to any material departures disclosed and explained in the financial statements; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charitable company will continue in business.

The Trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charitable company and to enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the charitable company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

So far as each of the Trustees is aware at the time the report is approved:

- There is no relevant information of which the independent Accountant is unaware; and
- The Trustees have taken all steps that they ought to have taken to make themselves aware of any relevant information and to establish that the Accountant is aware of that information.

**1. ACCOUNTING POLICIES**

1.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective January 2015), Charities SORP FRS 102 and the Companies Act 2006. The particular accounting policies adopted are described below.

1.2 Fund accounting

General funds are unrestricted funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the company and which have not been designated for other purposes.

Designated funds comprise unrestricted funds that have been set aside by the Trustees for particular purposes.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors which have been raised by the charity for particular purposes. The cost of raising and administering such funds are charged against the specific fund. The aim and use of each restricted fund is set out in the notes to the financial statements.

1.3 Incoming

Gifts in kind donated for distribution are included at valuation and recognised as income when they are distributed to the projects. Gifts donated for resale are included as income when they are sold. Donated facilities are included at the value to the company where this can be quantified and a third party is bearing the cost. No amounts are included in the financial statements for services donated by volunteers.

1.4 Expenditure

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is reported as part of the expenditure to which it relates. Support costs which cannot be directly attributed to particular projects are apportioned in proportion to the direct staff cost allocated to the project. Governance costs, which form part of Support costs include expenditure on the governance of the charity and its assets and are primarily associated with constitutional and statutory requirements.

Charitable expenditure consists of all expenditure relating to the objects of the Charity. All costs are directly attributable to the activities under which they have been analysed.

1.5 Tangible fixed asset and depreciation

All assets costing more than £200 are capitalised.

Depreciation is provided using the following rates and bases to reduce by annual instalments, the cost less estimated residual value, of tangible assets over the estimated useful lives:

- Fixtures & fittings - 33% straight line
- Office equipment - 33% straight line
- Building improvement - over 50 years

The Building improvement is now being depreciated as the building being put into use.

1.6 Foreign currencies

Assets and liabilities in foreign currencies are translated into sterling at the rates of exchange ruling at the balance sheet date. Transactions in foreign currencies are translated into sterling at the rate ruling on the date of the transaction. Exchange differences are taken into account in arriving at the net income/ (expenditure) result.

1.7 VAT

The charity is not registered for VAT and its expenses are therefore inflated by VAT which cannot be recovered.

1.8 Cash flow

The financial statements do not include a cash flow statement because the charitable company, as a small reporting entity, is exempt from the requirement to prepare such a statement under the Financial Reporting Standard 102 Section 1A (effective January 2015).

**14. OPERATING LEASE COMMITMENTS**

There were no lease commitments at the end of the year 2016 nor for 2015.

**15. SHARE CAPITAL**

The Swiss Church in London is a company limited by guarantee and has no share capital. Each member is liable to contribute a sum not exceeding £1 in the event of the charity being wound up.

**16. TAXATION**

The charity is not liable to tax on its charitable grants, donations or fee income earned in the course of its charitable activities, so long as the income is applied for the purposes of its charitable aims.
