- Daniel's forward looking statement to cover two elements

 - Actively looking for Trustees so that the Consistoire can carry out its role effectively.
 - Fundraising
 - Caroline has been hired for 2-4 days a month to support efforts over the next 18 months
 - Focus on Spiritual and Financial sustainability
